## Milford Active Growth Wholesale Fund

### Fund update for the quarter ending 30 June 2018

This fund update was first made publicly available on 26 July 2018.

#### What is the purpose of this update?

This document tells you how the Milford Active Growth Wholesale Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Aon Saver Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

This information is not audited and may be updated.

#### Description of this fund

The Milford Active Growth Wholesale Fund aims to produce returns well in excess of inflation by investing primarily in Australasian shares, with a moderate allocation to international shares and fixed interest securities.

#### What are the risks of investing?

Risk indicator for the Milford Active Growth Wholesale Fund.

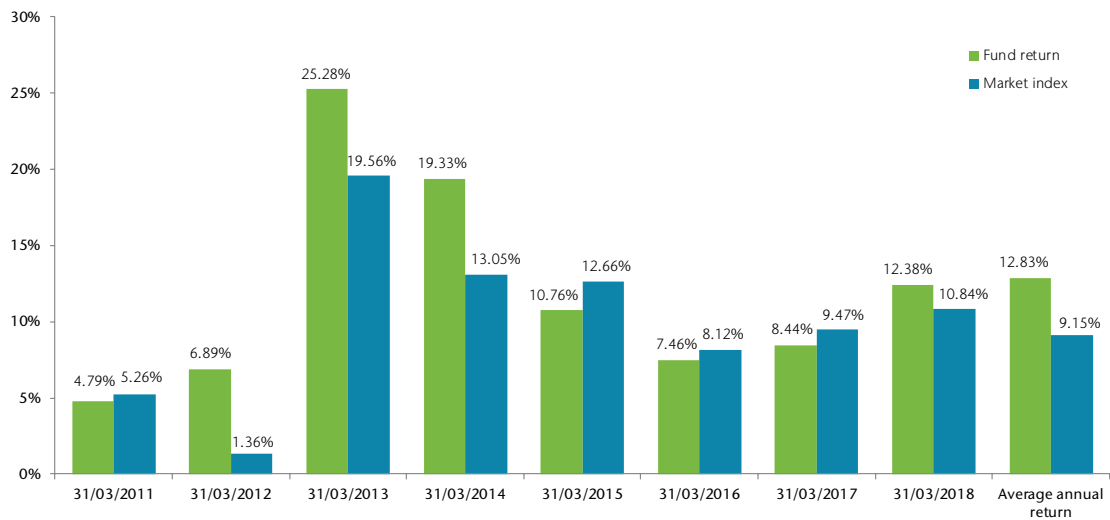
#### How has the fund performed?

\* Annual membership fees are the fixed dollar charges for membership in the Aon KiwiSaver Scheme, paid monthly. You will pay this fee only once each month even if you are invested in multiple funds within the Aon KiwiSaver Scheme. If you are under 18 this fee is reduced to \$40.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). 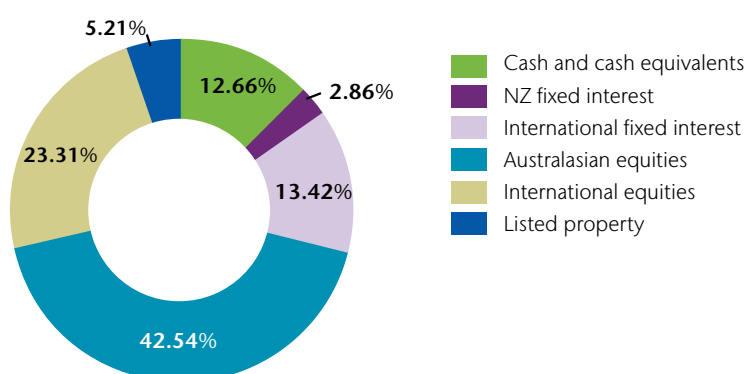
## Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of \$1,585 (that's 15.85% of his initial \$10,000). Jacob also paid \$49.80 in membership fees. This gives Jacob a total return of \$1,535.20 for the year.
