

## Annual Disclosure Statement for 1 April 2015 - 31 March 2016

### Aon KiwiSaver Scheme Aon - Nikko Cash Fund

#### What is the purpose of this statement?

This statement provides key information about the Aon KiwiSaver Scheme Aon - Nikko Cash Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

#### Description of the fund

The Aon - Nikko Cash Fund aims to provide investors with reliable income, while preserving capital value.

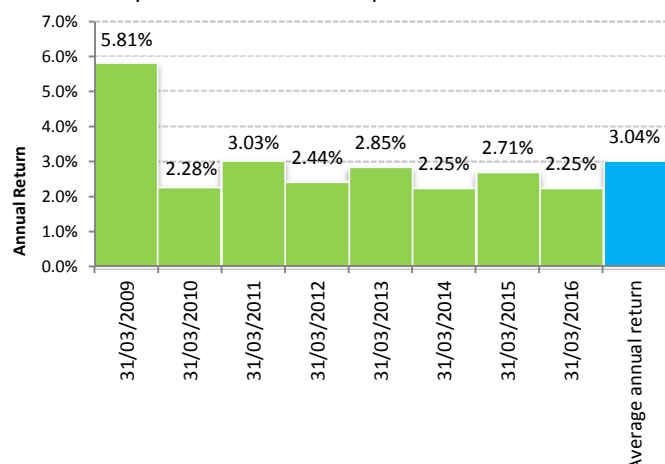

#### How has the fund performed in the past?

#### Example of how this applies to a member

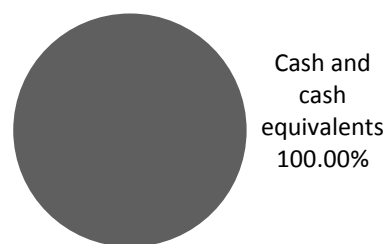
Jason had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jason received a return after fund fees and tax were deducted of \$225 (that's 2.25% of his initial \$10,000). Jason also paid \$49.80 in membership fees. This gives Jason a total return of \$175.20 for the year.
