Fund Update for the quarter ending 31 March 2017

This Fund Update was first made publicly available on 2 May 2017.

What is the purpose of this update?

This document tells you how the ANZ Balanced Fund has performed and what fees were charged. The document will help you to compare the Fund with other funds. Aon Saver Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

This information is not audited and may be updated.

Description of this Fund

The ANZ Balanced Fund aims to produce returns in excess of inflation. It has a target asset mix of 40% income and 60% growth.

What are the risks of investing?

Risk indicator for the ANZ Balanced Fund.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the Fund performed?

This shows the return after fund charges and tax for each complete year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 31 March 2017.

* The Manager expects that the reported total fund charges for the next scheme year will be higher by approximately 0.30% due to changes to the disclosure of underlying manager fees and changes in the level of performance fees. Some underlying fund fees are estimates as underlying fund managers change from time to time and underlying fund managers charge a variable performance fee at different times.

** Annual membership fees are the fixed dollar charges for membership in the Aon KiwiSaver Scheme, paid monthly. You will pay this fee only once each month even if you are invested in multiple funds within the Aon KiwiSaver Scheme. If you are under 18 this fee is reduced to \$40.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the 'Fee and other charges' document on the entry relating to the offer of interests in the Aon KiwiSaver Scheme maintained on the offer register business.govt.nz/disclose for more information about those fees.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of \$580 (that's 5.80% of his initial \$10,000). Jacob also paid \$49.80 in membership fees. This gives Jacob a total return of \$530.20 for the year.

Currency hedging
