

## Annual Disclosure Statement for 1 April 2015 - 31 March 2016

### Aon KiwiSaver Scheme Aon - Nikko Balanced Fund

#### What is the purpose of this statement?

This statement provides key information about the Aon KiwiSaver Scheme Aon - Nikko Balanced Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

#### Description of the fund

The Aon - Nikko Balanced Fund provides an active and diversified exposure to major New Zealand and international asset classes. The fund's objective is to provide investors with a balanced portfolio to outperform the benchmark (set by Nikko) by 1.5% pa before fees.

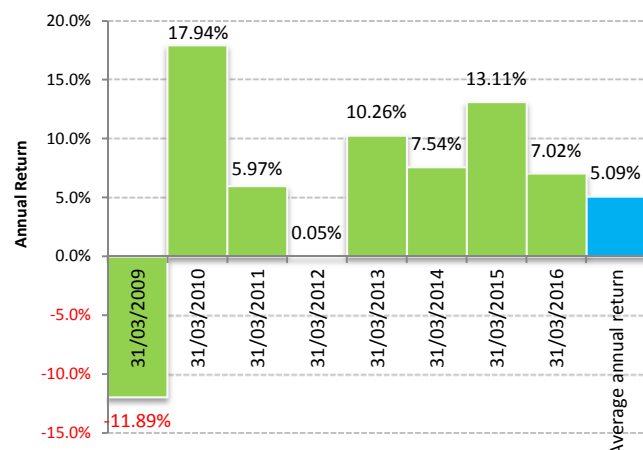

#### How has the fund performed in the past?

#### What fees were members charged?

The returns above are after deductions for **fund fees**<sup>2</sup>. Over the past year these were:

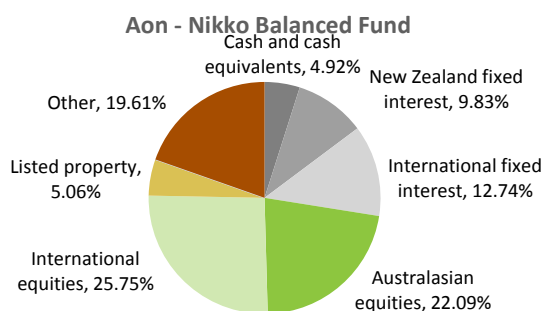
#### Example of how this applies to a member

Jason had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jason received a return after fund fees and tax were deducted of \$702 (that's 7.02% of his initial \$10,000). Jason also paid \$49.80 in membership fees. This gives Jason a total return of \$652.20 for the year.
