What is the purpose of this update?

This document tells you how the Russell LifePoints® Target Date 2015 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Aon Saver Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

Description of this fund

The Russell LifePoints® Target Date 2015 Fund aims to produce returns in excess of inflation by investing mostly in income assets with only a modest allocation to growth assets. This fund is closed to new investors.

What are the risks of investing?

Risk indicator for the Russell LifePoints® Target Date 2015 Fund.

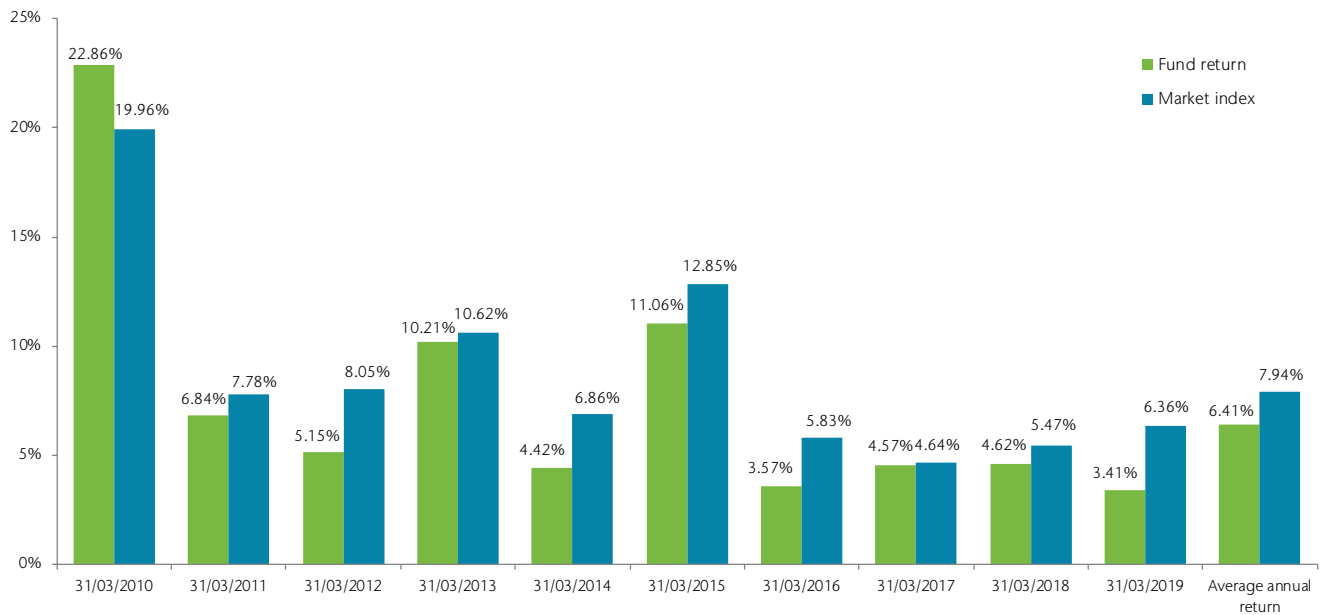
How has the fund performed?

* Annual membership fees are the fixed dollar charges for membership in the Aon KiwiSaver Scheme, paid monthly. You will pay this fee only once each month even if you are invested in multiple funds within the Aon KiwiSaver Scheme. If you are under 18 this fee is reduced to \$40.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Small differences in fees and charges can have a big impact on your investment over the long term.

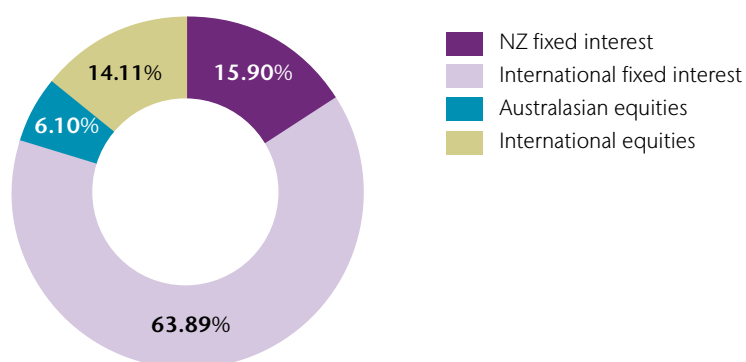
Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of \$609 (that's 6.09% of his initial \$10,000). Jacob also paid \$49.80 in membership fees. This gives Jacob a total return of \$559.20 for the year.
