This fund update was first made publicly available on 25 October 2019.

What is the purpose of this update?

This document tells you how the Nikko Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Aon Saver Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

Description of this fund

The Nikko Cash Fund aims to produce returns higher than bank deposits by investing in cash and short term fixed interest investments.

What are the risks of investing?

Risk indicator for the Nikko Cash Fund.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

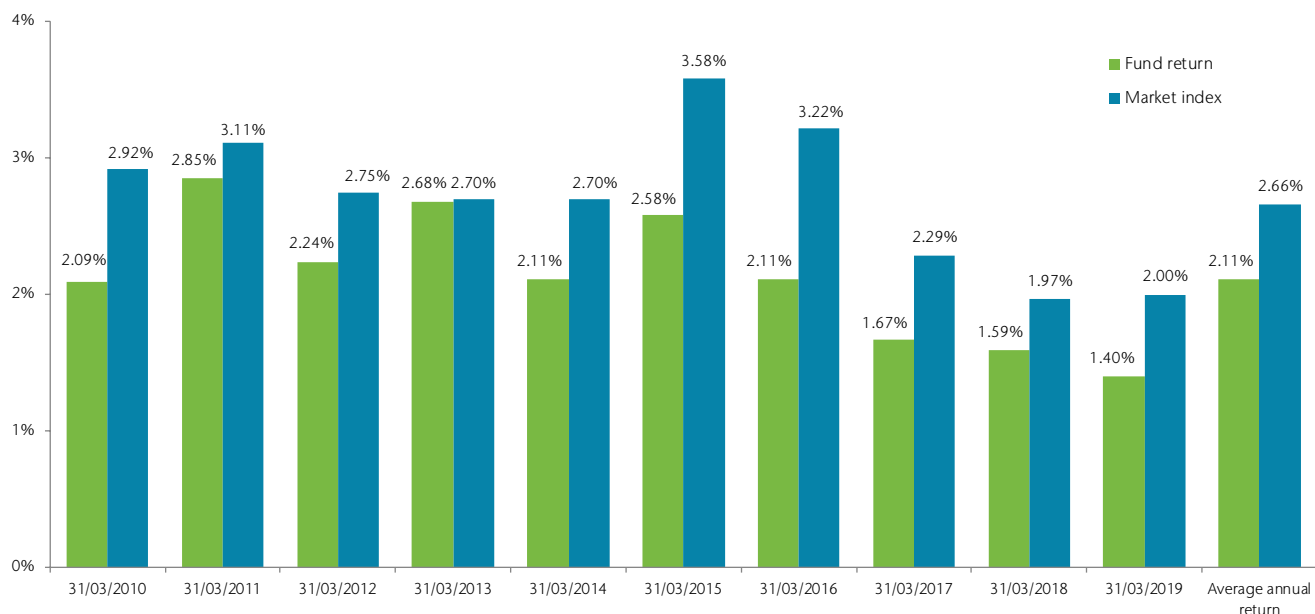
How has the fund performed?

* Annual membership fees are the fixed dollar charges for membership in the Aon KiwiSaver Scheme, paid monthly. You will pay this fee only once each month even if you are invested in multiple funds within the Aon KiwiSaver Scheme. If you are under 18 this fee is reduced to \$40.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Small differences in fees and charges can have a big impact on your investment over the long term.

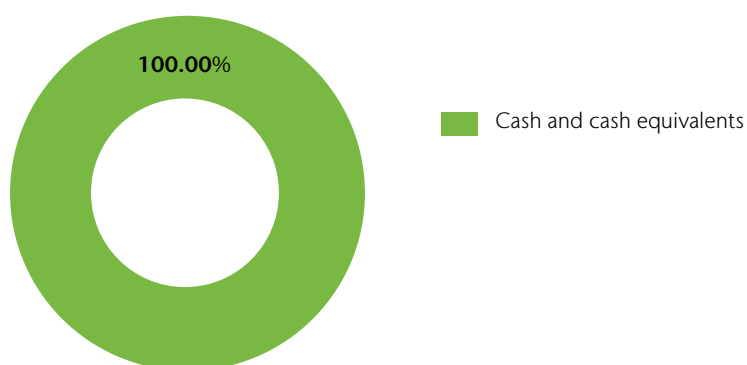
Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of \$144 (that's 1.44% of his initial \$10,000). Jacob also paid \$49.80 in membership fees. This gives Jacob a total return of \$94.20 for the year.
